Setting up your LLC so you have 100% anonymity

Two states give you the strongest anonymity for an LLC

- Wyoming
- Nevada

You stay anonymous because the state does not require your name on public records

- You list a registered agent only
- You avoid public filings with your personal info

Best choice for strict privacy

- Wyoming
 - No public owner records
 - Strong liability protection
 - Low annual fees
 - Quick filing

Nevada also hides owners, but costs more and attracts extra scrutiny.

How to keep anonymity after formation

- Use a registered agent to handle all public filings
- Use an EIN that does not expose your name
- Use a business mailing address that is not your home

Setting up your LLC so you have 100% anonymity

How to buy assets through the LLC:

- Open an LLC bank account. Bring your Articles of Organization and EIN
- Fund the account. Keep personal funds separate
- Conduct all purchases in the LLC name. This includes contracts, bills, and receipts
- Keep clean records for taxes

How to buy digital assets through the LLC:

- Open a crypto exchange account using the LLC name, LLC bank account, and LLC documents.
- Use a dedicated business wallet.
- Store keys in a hardware wallet controlled by the company.
- Keep a transaction log for each purchase.

You get stronger privacy when every asset flows through the LLC's bank account and the LLC's crypto wallet.

Setting up your LLC so you have 100% anonymity

Key points to watch:

- Use a lawyer to review your operating agreement. It keeps your control private.
- Avoid putting your personal name on utility bills, leases, or service accounts linked to the LLC.
- Use a virtual business address, not your home address.
- Keep a separate phone number for the LLC.
- Renew your LLC on time to avoid gaps in privacy.
- Do not mix personal money with LLC money.
- Keep all contracts signed using your title, not your personal name.
- Use a nominee manager if you want another layer of privacy.
- Use privacy-focused email for all LLC activity.
- Avoid social media or public sites that connect your name to the LLC.

Protection breakdown:

IDENTITY PROTECTION

- Use a registered agent so your name stays off state records
- Use a business address from day one
- Use an EIN instead of your SSN for all accounts
- Use a privacy-oriented phone service

FINANCIAL PROTECTION

- Open a bank account in the LLC name.
- Keep clean separation between personal and business spending.
- Keep receipts and contracts under the LLC.

Setting up your LLC so you have 100% anonymity

LEGAL PROTECTION

- Use an operating agreement that defines ownership without public filing
- Sign as Member or Manager. Avoid using your full personal name alone
- Maintain annual reports and fees
- Keep liability insurance for the LLC

ASSET PROTECTION

- Register property, vehicles, or equipment under the LLC.
- For digital assets, use hardware wallets owned by the LLC.
- Keep seed phrases stored using a business safe or offsite storage
- Use exchange accounts opened under the LLC.
- Keep a log of all digital asset transactions.

PRIVACY PROTECTION

- Limit who knows you own the LLC
- Use encrypted storage for sensitive documents
- Use a VPN for all digital asset activity
- Avoid linking personal email or phone to crypto platforms

This structure keeps your identity disconnected from ownership and keeps your personal assets insulated from business risks.

Setting up your LLC so you have 100% anonymity

REGISTERED AGENT

- Keeps your name off state records
- Use an agent in Wyoming or Nevada for stronger privacy
- Choose an agent that never posts owner info online
- Provides a legal address for service of process
- Use their address on all public filings

OPERATING AGREEMENT

- Defines ownership without public disclosure
- Keep it offline and stored in a secure location
- Protects you in disputes
- Update it when ownership changes

BUSINESS ADDRESS

- Avoid using your home address
 - Use a virtual office or commercial mailbox with mail forwarding
- Avoid USPS boxes since some banks reject them
- Keep your home address off every document
- Do not list it on invoices or emails

SEPARATE PHONE NUMBER (BUSINESS PHONE NUMBER)

- Use VoIP or a business line.
- Keep this number on all bank and exchange accounts.
- Avoid linking your personal phone.
- Create a clean separation between business and personal identity.

Setting up your LLC so you have 100% anonymity

ANNUAL RENEWAL

- Missed filings expose your LLC to penalties
- Set reminders for 30 and 7 days before deadlines
- Renewal keeps anonymity active
- Your registered agent can submit renewals for you

NO MIXING OF FUNDS

- Keep personal and business money separate
- Use dedicated business checking and savings
- Use the LLC bank account for every expense
- Avoid personal reimbursements unless documented

SIGNING DOCUMENTS

- Sign using your title like Manager or Member.
- Avoid signing with personal name alone.
- Always attach the LLC name in signatures.
- This protects liability coverage.

NOMINEE MANAGER

- Adds an extra privacy layer on public records
- You control everything through internal documents
- Useful for high-profile owners
- Not required for most people

Setting up your LLC so you have 100% anonymity

PRIVACY EMAIL

- Use a business-only email
- Providers like Proton Mail or Tutanota give stronger privacy
- Avoid linking personal emails
- Use business email for banks and crypto platforms

AVOID PUBLIC LINKS

- Keep LLC off social media profiles
- Do not list your role publicly
- Avoid sharing address or mailbox photos
- t weakens your privacy trail

IDENTITY PROTECTION

- Use registered agent address on all filings
- Never list your residential address
- Apply for EIN using LLC details
- Use EIN for every finance or crypto platform

FINANCIAL PROTECTION

- Open a business bank account in the LLC name
- Use EIN and Articles of Organization
- Keep clean bookkeeping
- Store digital receipts in organized folders
- Use business debit or credit
- Avoid personal cards for purchases

Setting up your LLC so you have 100% anonymity

LEGAL PROTECTION

- Maintain updated operating agreement
- Reflect roles and ownership
- File all state reports on time
- Save confirmed filings
- Carry liability insurance
- Choose coverage based on your activity

ASSET PROTECTION

- Title property in the LLC name
- Update vehicle titles and real estate records
- Keep equipment under LLC ownership
- List assets clearly for insurance

DIGITAL ASSET PROTECTION

- Use hardware wallets owned by the LLC
- Ledger and Trezor support business use
- Store seed phrases in a safe location
- Use fireproof storage or safety deposit boxes
- Log all transactions
- Track wallet addresses and dates
- Use exchange accounts opened under the LLC
- Connect only the LLC bank account

PRIVACY PROTECTION

- Limit who knows you own the LLC
- Only disclose when legally required
- Use encrypted document storage
- Keep backup copies offline

- Do not list your Florida address on any federal or state documents
 - Keep everything tied to Wyoming
 - Use a privacy-friendly accountant
 - Provide only EIN and operating agreement when needed
 - Use Wyoming address for bank, crypto, and platform accounts
 - Ensures no Florida connection appears
 - Keep personal identity offline
 - Use business email, phone, and address only

FORMING THE WYOMING LLC

- File Articles of Organization with a Wyoming registered agent
- Use the registered agent's Wyoming address on all filings
- Do not list your home state address
- Use a virtual office or mailbox in Wyoming for mail

EIN SETUP

- Apply for EIN using the Wyoming LLC name and address
- Use a business email and phone tied to the Wyoming LLC

Setting up your LLC so you have 100% anonymity

BANKING

- Open a business bank account using the Wyoming documents and EIN.
- Use the Wyoming address for bank verification.

OPERATING FROM YOUR HOME STATE

- Run your business from home without listing your state address publicly
- Only your Wyoming registered agent and virtual office appear in public records

FOREIGN REGISTRATION REQUIREMENT

These states require foreign registration only if you:

- Maintain a physical office in the state
- Hire employees there
- Store inventory in state
- Meet clients in person regularly
 - Online business activity alone does not trigger foreign registration

MAINTAINING ANONYMITY

- Use the Wyoming address on all filings, bank accounts, and platforms.
- Keep your personal identity offline.
- Use a privacy-focused accountant.
- Keep business email and phone separate from personal accounts.

Setting up your LLC so you have 100% anonymity

DIGITAL AND PHYSICAL ASSETS

- Open crypto exchange accounts using Wyoming LLC info
- Use LLC-owned hardware wallets for digital assets
- Title physical assets under the LLC
- Keep separate records for LLC assets

ANNUAL REQUIREMENTS

- File the Wyoming annual report.
- Keep the registered agent active.
- Maintain a small annual fee to protect anonymity

No matter what state you live which is the best state to setup your LLC so you have 100% anonymity
